

#### Operation

 Set current time by rotating Dial so that the black arrow is pointing at the correct time.

Note: Timer uses a 24 hour day (A.M. hours are 1 to 12, P.M. hours are 13 to 24) Example: 2 P.M. = 14.

- Each Indicator around the Dial represents 15 minutes. Depress Indicator to supply power to Side Outlet at designated time. Example: To set Timer to go on at 8 P.M. and off at 6 A.M., all indicators between 20 and 6 must be pressed down.
- Plug appliance(s) into Outlets on either side of Timer. Slide Power Switch up to turn Timer on. Move Power Switch down to turn Timer off.
