- 1. To change lantern intensity, press the "Lantern" switch to switch between High, Medium, Low, and Off.
- 2. To change fan LED mode, press the "Lighting" switch to switch between 100%, 50%, 20%, and Off.
- To change fan speed, press the "Fan" switch to switch between Low, Medium, High, and Off.




Figure A: Button Layout

Micro USB Input and USB Output

- Move USB port cover. Note: The cover cannot be completely removed from the item.
- 2. Use micro USB cable to charge item.
- Charging indicator will turn red while charging. Charging indicator will turn green after the item is fully charged.
- 4. After the product is fully charged, a mobile device can be charged via the larger USB Output port.




Figure B: Port Layout


Battery Removal and Disposal
