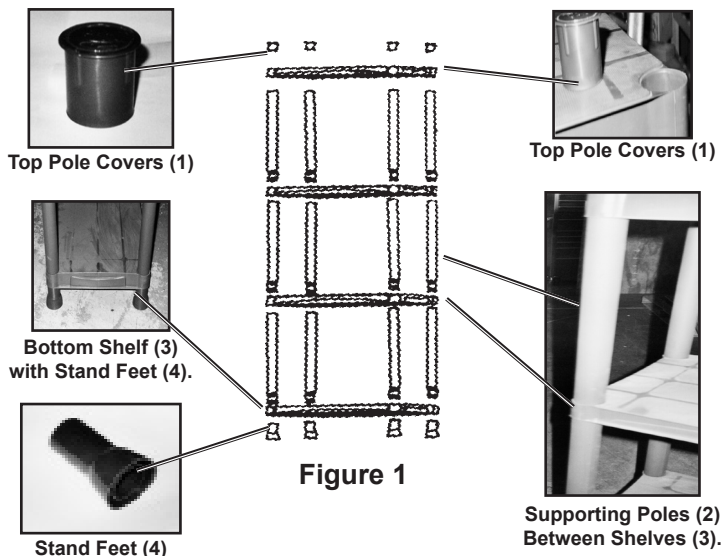

ASSEMBLY INSTRUCTIONS

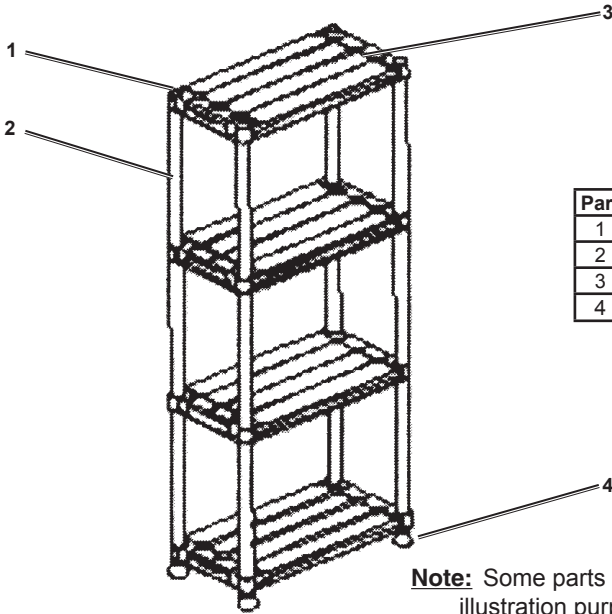
1. Attach each Shelf (3) with the Supporting Poles (2) as shown in **Figure 1**. It is recommended that you start assembling bottom shelves first and work upward.
2. On the bottom Shelf (3), push in the four Stand Feet (4). **See Figure 1**. Stand Shelf Rack upright. Tap on the Top Pole Covers (1) in the holes in the top Shelf (3) for a finished look. Check to see that the Shelf Rack is level.

CAUTION! Distribute weight evenly on shelves. Each shelf has a capacity of 44 lb. maximum. Place Shelf Rack on a smooth, hard, level surface.
